**PLAYER AGREEMENT WITH BOWLS NT  
AVAILABILITY FOR SELECTION AND ASSOCIATED CONDITIONS  
REGARDING NT 2019 REPRESENTATIVE SIDES WHICH INCLUDES  
THE SENIOR'S REPRESENTATIVE TEAM**

I, (full name) \_\_\_\_\_

being a financial member of the \_\_\_\_\_ Club

hereby agree that:

- A. I have read all the terms and conditions of this agreement and understand, accept and agree to be bound by all the terms and conditions of this agreement.
- B. Failure to attend all scheduled training sessions without giving adequate notice to either the Side Coach or the Side Manager, and without a sufficiently valid reason in the opinion of the Side Coach or Side Manager, may result in exclusion from either the Training Squad or the Bowls NT Representative Side (Side).
- C. Behaviour that is detrimental to the Training Squad or the Side in the opinion of the Side Coach or Side Manager may result in exclusion from either the Training Squad or the Side.
- D. I will undertake any training that may be required in addition to the formally convened squad training sessions.
- E. I will participate in any fundraising that may be required.
- F. I will seek to improve my current level of physical fitness.
- G. I will positively encourage and support other Squad or Side members.
- H. I will attend official team or squad social functions as required.

I also agree:-

1. To remain under the control, management and direction of the Side Manager from the date of appointment of the Side Manager (date to be advised by Bowls NT) until either returning to the place of departure or by an authorized release from the Side, and to comply with all orders and instructions given by the Side Manager during this period.

2. To comply with any lawful direction given by the Side Manager without argument or disputation at the time any direction is given.
3. To be under the control, management and direction of the Side Coach/ Side Manager during scheduled training sessions for the Side before, during and after competition matches.
4. That if I am absent from scheduled training sessions, valid reasons notwithstanding, at some point in time the Side Manager, with the overall interests of the Side in mind, may be required to make a decision adverse to me regarding the ongoing composition of the Side in order to ensure that the Side and its teams train and develop together in a cohesive and optimal manner.
5. To travel with the Side and depart to and return from the competition in accordance with the travel arrangements set and approved by Bowls NT. I accept all travel & accommodation details & decisions are made between Bowls NT & BA.
6. To conduct myself in a manner that will encourage and support the harmony of my team and the Side as a whole, dress properly at all times (including, when directed, wearing the official Bowls NT walk out uniform), use my best endeavours in the competition, observe curfews (if any), limit the use of alcohol, and do any other thing as may be required to maximise the Side's performance.
7. That no alcohol is to be consumed on a competition match day before 6pm, or until after the players rink card has been signed by both skips & central umpire, unless expressly permitted by the Side Manager. I agree that I will manage my consumption of alcohol so as not to affect my performance.
8. To promptly comply with all pre departure requirements such as answering questionnaires, filling out forms, answering correspondence, paying for costs related to the Side's official walk out and playing uniforms (as applicable) and any player contribution as may be determined by Bowls NT. I accept that any contribution determined by BNT **shall** be paid by myself as directed, no later than 6 weeks prior to going.
9. That friends or family members of players wishing to attend the competition are responsible for making their own travel & accommodation arrangements.
10. To be thoroughly familiar with the Side itinerary, competition programme and all protocol arrangements to ensure my timely attendance at events or ceremonies.
11. To stay with the Side at all times at the designated accommodation and not be absent at any time unless approved by the Side Manager.
12. I will not supply any information to the press, radio or television except with the approval of the Side Manager.
13. To be financially responsible for any fees for excess luggage above and over the permitted weight.

14. To make full disclosure to the Side Manager of any diagnosis or treatment that a medical practitioner has made or prescribed for me which in any way may affect my own or the Side's performance or that may constitute a danger to any other person no matter how remote that possibility may be.
15. To make myself familiar with requirements regarding prohibited drugs in sport and to complete the ASADA athlete accreditation.
16. That Bowls NT is under no obligation to recompense me for any loss that is caused by, or as a result of any situation, act or omission beyond the control of Bowls NT.
17. To make myself available for all pre-competition challenge matches.
18. That if I breach this agreement the following penalties may be imposed upon me by the Side Manager or by Bowls NT at his, her or its discretion:-
  - (a) imposition of a fine not exceeding \$100.
  - (b) suspension from the Side (or the Training Squad if applicable) for a specific period during the tour, the minimum being 1 competition match.
  - (c) dismissal from the Side (or the Training Squad if applicable) and/or expulsion from the tour.
  - (d) withdrawal of any or all financial assistance.
  - (e) reimbursement by me of all or part of any expenses incurred by Bowls NT by virtue of my selection.
  - (f) any other action taken by Bowls NT in accordance with its Constitution and By Laws.
19. I note, understand and accept that the powers described at 18 (a), (b) and (c) above are delegated by Bowls NT to the Side Manager from the time of his/her appointment until the time I return from the competition or am otherwise released.
20. That any such determination of penalty shall take effect on written receipt by the player of the penalty.
21. That the Side Manager will upon his/her return to the NT provide Bowls NT with a written report on any determination of penalty that was given to a player/s during the competition.
22. That my rights of appeal in relation to imposition of any penalty are only those set out in the Bowls NT Constitution and By-Laws.
23. That I will return my allocated playing uniform to Bowls NT at the time and place directed within 4 weeks of the finish of the competition.
24. If you wish to purchase Bowls NT State Uniforms, they are not to be worn other than state representative competitions.
