Bowls Victoria have done such at times, speaking with CEO of Bowls Australia he believes it is a State decision. Decision made that we would support and allow posting all information on our facebook supporting the sport.

Draft document was distributed to Board members for comments. Referred back to the EO who will work with Peter Shepherd during the review processes. The intention is this will be presented to Clubs by end of June for acceptance and/or change.

#### 8.4 Video / Audio Equipment

#### Comment

Progress is being made. Barry has advised he believes quotation will be close to \$10k and is talking to Aidan at Bowls Australia, along with Bowls Tas and Bowls SA' Whilst this would be a great initiative we would need to identify how, who would be using within the processes.

#### 8.5 Vehicle Signage

Vehicle has been photographed by Design city who will do design for consideration. I have met again also with Kia and their rough idea was that their intended spend would be about \$500. I pointed out we were looking at a part potential skin on the vehicle to assist promotion and that we would like to as joint situation offer them promotion on the State events scoring cards. Discussions were good ,amicable and I would anticipate likelihood is their spend will double. This should all workout over the next fortnight and EO will get details to Board before next meeting so we can push this forward.

#### 8.8 Peak Body Report.

Peter Shepherd is due for a meeting with EO. He managed to also meet with people in Alice Springs and Tennant Creek whilst he was down that way last week to discuss and source information to assist the sport and our plan.

#### 8.9 Umpiring and markers potential course.

Ongoing. Bowls Australia are moving to online training opportunities. EO is also due to complete assessors and presenters course soon so this will provide opportunities both ways.

#### 8.10 Insurance

Policy renewal cost \$7200 including ability for monthly deductions. Cost last year was \$8062. We cannot just compare the amounts and say cheaper there were reasons at both ends. Within last year's amount there was additional payments of approx. \$1400 which increased the funded amount, in this year's we have the vehicle cover cost \$1197 with such being insured for 14 months to meet within the normal policy expiry date. In addition parts of cover also deleted with Bowls Australia paying workers compensation.

#### 8.11 Uniforms

Proposal discussed. Jen Sullivan and EO to meet to decide how best we can replace uniforms, what do we need to supply and commence quotation and design processes.
