Clearances.

Intrastate

Clearances can be done directly through Bowlslink where it involves a clearance from one NT Club to another NT Club. There is no need for the player or Club to complete paperwork. The responsibility is one both of the Clubs and the player to ensure they are not doubling up on entering any Club events.

The Club where the player is heading instigates such within Bowlslink and the Club they are going to, the player and Bowls NT are all notified within the system. These bodies can approve or decline such a clearance request.

Interstate

As it sits at the moment ALL clearances must be done with paper requested clearances. Such should be done by the old Club and the paperwork sent to the new intending Club for the player.

In all cases such must be approved and signed off at the State level being Bowls NT and the State from where clearance is originating.

<u>Failure to attend this will result in the player being ineligible to compete in any Club events.</u> State Events and pennant.

Should clearances not be attend correctly penalties will be applied.

Pennant Declarations.

These paper forms can be used to enable a player to compete in a pennant game at another Club be it locally or interstate. Such document does not allow the player to play in any Club events just pennant. Such must be approved by the State body.

Again these must be in place prior to the player competing in any pennant game penalties will be included within the NT Pennant conditions of play but will likely include loss of points and potential fin

Carnival Events.

To ensure there is a clear understanding Clubs should be fully aware –

All registered Ranking events must FULLY comply with the Bowls Australia National Merchandising Policy and such must be included within the Conditions of Play.

A copy of such Conditions should be forwarded to the Bowls NT at least a week prior to commencement of the Carnival events.

All players competing in Events must be Full affiliated members of a Bowls Club and not be a Social or recreational bowler.
