Financials profit / loss to 30 June 2024 report a loss this Year of \$30,655 which was anticipated. Majority of this comes from Australia Sides and other rising costs such as travel expenses flights etc.

Our PSB Grant has been submitted and initial indications are that we will receive an annual increase to \$125,000 which will be \$625,000 over five years but this is conditional on annual reviews. The importance of Clubs in being able to keep statistics on participation levels and increases in their membership will never be more important so we are assured of keeping Grant at that level.
